Ntabankulu Local Municipality is calling upon experienced, competent, and qualified service providers to tender for the rendering of **maintenance of five municipal High Mast Lights**.

Bids are to be completed in accordance with the conditions attached to the Bid document and must be sealed and endorsed with the relevant bid number and must be deposited in the official bid box clearly marked **"PROVISION OF MAINTENANCE SERVICES FOR MUNICIPAL HIGH MAST LIGHTS: BID NO: NLM/TS/PMSMHML/2020/2021 in the main entrance** of the Ntabankulu Municipality at ERF 85, Main Street, Ntabankulu, 5130 not later than **12h00 on 09<sup>th</sup> of April 2021**, at which time bids will be opened in public. Bids shall be valid for a period of 90 days after the closing date of the submission of bids. **Under no circumstances will late tenders be accepted.**

Service providers are requested to attach these requirements for their bids on the pages indicated in the document:

- Valid Tax SARS compliance pin
- Proof of company registration
- Certified ID copies for the entity owners
- Health and safety plan

- Valid original or certified copy of BBBEE Verification Certificate to claim Preferential points
- Company profile will all completed projects, CV's of Employees
- Proof of municipal rates clearance or a signed lease agreement by both parties or confirmation that there is no billing where the entity is based
- A trust, consortium or joint venture must submit a consolidated B-BBEE status level verification certificate for every separate bid and a joint venture agreement.
- All prospective service providers are required to apply on Central Supplier Database in order to do business with all organs of the State in the Republic of South Africa at <https://secured.csd.gov.za>. Non-registration will be regarded as non-responsive and be disqualified from the bid.

**NB. It is a requirement that all bidders must submit all the above documents.**

**Functionality will be evaluated based on capacity and experience. Bidders who failed to score a minimum functionally assessment of 70% will be considered non-responsive and will not be evaluated further.**

EXPERTISE</b> CV of proposed project team</p> <ul style="list-style-type: none"> <li>• 15 points for Certificate in electrical artisan with trade test</li> <li>• 10 points for Certificate of Compliance</li> <li>• 5 points for health and safety personnel with certificate and proven experience</li> </ul>	30 points
<p><b>3. METHODOLOGY</b> Submission of methodology that reflects value-add</p> <ul style="list-style-type: none"> <li>• 10 points for availability of vehicle</li> <li>• 30 points for availability of 100m winch</li> </ul>	40 points

The primary criteria in selection will be cost and BBBEE status level of contribution. 80/20 Preference Points System will be used as per NTABANKULU LOCAL MUNICIPALITY Supply Chain Management policy. 80 points shall be for Financial Offer and 20 points for the BBBEE level contributor which will be evaluated as follows:
