

SPECIFICATION

- A cage must be made from 38 x38 square tube steel.
- Expanded mesh net with a lockable gate of 25 x25 square tube steel.
- A mesh open roof with closed bottom by HR sheet.
- The cage dimensions must be 2 x3x2m (Lx B x H).
- The gate must have a bolt lock.
